
The town clerk shall properly post this resolution as required by law under s. 60.80 of Wis. Statutes within 30 days of the below noted adoption date.





**Resolution to Approve Total Highway Expenditures and  
to exceed the limits in Section 82.03(2) of WI Statutes**

Whereas, section 82.03(2) of WI statutes allows the town electors to exceed the highway expenditure limit \$5000 per mile of town highway.

Whereas, the Town Board has adopted a resolution setting highway expenditures in an amount in excess of the statutory limit.

Whereas, this special town meeting of the electors has been called and noticed to consider the adoption of the resolution to exceed the highway limits.

Now, therefore, the special town meeting of the Town of Walworth, Walworth County, Wisconsin, by a majority vote of the eligible electors voting on this 11<sup>th</sup> day of November, 2014 duly assembled and voting resolves and orders as follows:



WHEREAS, there is a need to adopt the 2015 Budget for the Town of Walworth.


NOW THEREFORE, the Town Board of the Town of Walworth, Walworth County, Wisconsin does hereby resolve:


1) The 2015 Budget will be adopted in the amount of \$1,173,760.24 as follows:
