ORDINANCE NO. 2004-08

AN ORDINANCE RESTRICTING THE SALE OF FIREWORKS  
FOR THE TOWN OF WALWORTH, WALWORTH COUNTY, WISCONSIN

(SALE OF FIREWORKS RESTRICTED)

THE TOWN BOARD OF THE TOWN OF WALWORTH DOES HEREBY ORDAIN AS  
FOLLOWS:


SECTION ONE:

- A. Except as provided in Section 167.10(2) and (4), Wisconsin Statutes, no person shall sell or possess, with the intent to sell, fireworks. (Prior code § 9.03(2)).
- B. In accord with Sec. 167.10(5)(b), *Wis. Statutes*, which authorizes towns to adopt regulations of fireworks which are more restrictive than is the said statute, the Town hereby declares that it is illegal for any person, acting as a wholesaler, to possess and sell at wholesale, any fireworks within the Town. For the purposes of this subsection, "wholesaler" shall mean any person who is engaged in the sale of goods or commodities in quantity for resale or any person who sells fireworks to persons outside of this state.


SECTION TWO:
