TO ACCEPT THE CONVEYANCE OF PROPERTY AND TRUST FUNDS FROM
THE BRICK CHURCH CEMETERY ASSOCIATION

RECITALS

- A. The Town Board of the Town of Walworth, Walworth County, Wisconsin (hereinafter "the Town"), pursuant to §157.064(5), Wis. Stats. has the authority to accept the conveyance of property and trust funds from a cemetery association.
- B. The Brick Church Cemetery Association (the "Association") has voted to convey the real estate legally described on Addendum "A" attached hereto (hereinafter the "Property") together with its trust funds to the Town.
- C. The Town Board believes that, pursuant to §157.064(5), Wis. Stats., it is in the best interest of the Town to accept the conveyance of the Property and the Trust Funds and to continue maintaining the Property as a cemetery.

NOW, THEREFORE, BE IT RESOLVED that the Town Board, pursuant to §157.064(5), Wis. Stats., hereby accepts the conveyance of the Property and the Trust Funds from the Association effective April 25, 2017.


BE IT THEREFORE FURTHER RESOLVED that the Trust Funds shall be paid to the Town's Brick Church Cemetery budget.






